Sub :- Instruction for resumption of election of Delegate, BOD & Officer Bearer of Visva Bharati Co-operative Credit Society Ltd. denovo, under the jurisdiction of Bolpur Sriniketan Development Block.

Whereas, the delegate election of Visva Bharati Co-operative Credit Society Ltd. was started denovo as per the instruction of the Cooperative Election Commission vide memo no. 283-CEC/IV-01/2025 dated 15/05/2025.

And

Whereas, the Delegate Election of Visva Bharati Co-operative Credit Society Ltd was postponed by the order of Returning Officer & Assistant Registrar of Co-operative Societies owing to unavailability of Police Personnel as intimated by the Officer in Charge, Santiniketan Police Station, Vide Memo. No. Nil, Dated: -23/07/2025.

And

Whereas, the date of the delegate election was scheduled to be held on 27/07/2025 and more than one year was passed after the postponement of the above said election.

And

Whereas, two contesting candidates and 86 no. of members were retired from their respective services within the above-mentioned specified time frame. Thus, the ability of participating in the election (Two Candidates) & ability of casting their votes (86 no of members) had also been also lost.

Now therefore, it is being ordered to Shri Tathagata Saha, Assistant Returning Officer & Inspector of Co-operative Societies, Bolpur Sriniketan Development Block, Sriniketan, Birbhum, to start the Delegate Election of the above said Co-operative Society denovo. Again, you are also instructed to follow Section 32 of West Bengal Co-operative Societies Act, 2006, related Rules as mentioned in West Bengal Co-operative Rules, 2011 & guidelines framed by Co-operative Election Commission, West Bengal, Vide No. 15/ CEC, Dated: -13/04/2012 and also instructed to submit the report to the undersigned after the completion of the entire electoral process.
