2. Members intend to file the nomination, must follow the **schedule published** for this election.
3. Members intend to file nomination, are instructed to fill his/ her name **ENGLISH (Block Letter) and BENGALI** in his/ her Nomination Form.
4. Members intend to file the nomination, must submit any **one copy (Self attested) of his/ her photo identity(issued by any Govt authority)** during the submission of his / her Nomination Form.
5. Members intend to file the nomination, **must produce Authorization letter if he /she sends his /her representative during the distribution or submission of the Nomination Form.**
6. The candidate **must submit his/ her application to the Assistant Returning Officer (s) physically if he/ she intends to withdraw his / her nomination.**
7. **Defaulter members** do not able to participate in the **delegate election but he / she can cast his/ her vote in this election.**
8. **Voters must carry their photo identity in original (issued by any Govt authority) during casting their votes.**
