So that the changes may not be avoided in the election constituencies & Reservation of Seats for SC/ST & Women (as directed by Co-operative Election Commission, WB) . The direction of Co-operative Election Commission, WB is being attached as ANNEXURE- A. The list (Signed by the Manager of Visva Bharati Co-operative Credit Society Ltd) of the retired members is being attached herewith for your kind information as ANNEXUE -B.

This Co-operative Society also has the Pensioners & family Pensioners Members but the above mentioned retired members is being deprived from getting membership as Pensioners members as the management of this Co-operative Society is being run by the Special Officer. But these members are also enlisted as valid voters in the Final Voter List published on 22/05/2025.

This is why problems may be arrived during the poll if the voter list is drawn for the rectification and the no. of retirement is gradually showing an increasing trend being a part of dynamicity.

No death of Candidates & Members have not been reported from the concerned Co-operative society to the undersigned.

Therefore, you are requested to consider the above mentioned phenomena and also requested to guide the undersigned to take the future course of action in connection with the above said Delegate Election.

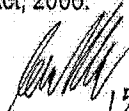

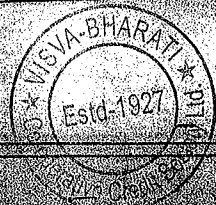

In connection with the subject and reference cited above, this is to inform you that :-

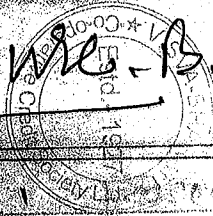
1. Membership may be scrutinised by fixing a cut off date even after publication of final voter list, if gross anomalies detected as per Order passed by the Hon'ble Supreme Court in connection with the SLP No. 13916 of 2024. You may also proceed for reviewing and correction of final voter list in the same manner if gross anomalies detected. Election schedule may be published denovo in that case.
2. The essence of the provision U/s 32/1(a) of the WBCS Act, 2006 is to maintain reservation of 2(two) seats for women and (1) one seat for Schedule Casts or the Schedule Tribes on the Board of Cooperative Societies having individual members. Hence you are advised to proceed for Delegate Election keeping in mind to maintain minimum participation of the women and the Schedule Casts or the Schedule Tribes in the BOD U/s 32/1(a) of the WBCS Act, 2006.
